## LAW LIBRARY ADVISORS' MEETING

Review and approve the Minutes of the Law Library Advisors' Meeting dated August 25, 2021.

They would like the Advisors to give a list of recommendations of things they would like to see in a person to replace Norma. Hillsborough County Ordinance 14-27 the HCBA member must be "a Director of the Hillsborough

County Bar Association". Paige informed the Advisors that she will make aware the HCBA's Board

of Directors that a new Law Library Advisor will need to be appointed when her term ends.

b. James Schmidt requested Jane Rose to provide details from the Advisors' governing documents

regarding the duties and responsibilities of the Advisors.

c. A discussion ensued concerning the John F. Germany's Friends of the Library and any money

needed for the Law Library would continue to be covered by them. Norma Wise was asked to

leave the meeting for this discussion. When she returned, she was informed that Lisa Wagner

would be attending the Friends of the Library meeting soon and would request any money needed

for the planning for Law Week with members of the Hillsborough County Bar Association.
